The Buildings Energy Efficiency Ordinance (Cap 610) had been enacted in November 2010. The Ordinance will come into full operation on 21 September 2012.

In addition, it is estimated that the Mandatory Building Inspection Scheme and Mandatory Window Inspection Scheme under the Buildings (Amendment) Ordinance 2011 will be implemented in 2012 at the earliest.
