Lifts are one of the safest forms of transport as they are designed based on strict and comprehensive standards. However, standards change to reflect developing technology and social trends. In Hong Kong, there are about 70 000 lifts and more than half of the existing lifts are aged over 20 years old. This is most significant when compared with technological advancement over such a time span and raised personal expectations of safety levels. Therefore, long term strategies and possible actions would like to be introduced for enhancing safety and management of aged lifts.</li> </ul>
