Content	Central Market is one of the oldest wet markets and an architectural landmark in Hong Kong. The current fourth generation of Central Market was built in 1939. It has undergone a contemporary renovation as part of a conservation and revitalization project by the Urban Renewal Authority. The restoration and preservation works for this 80-year-old Grade Three historic building have maintained its original appearance, structure, and features. The Market has multiple entrances, each leading into different sections. The building incorporates functionalism on each floor, with traditional terrazzo and Shanghai plastering widely used. Lampshades hanging throughout the market symbolize its classic wet market identity, and the historical red brick walls serve as a testament to its predecessor. The Central Market also embraces the concept of an urban oasis, incorporating green plants. Additionally, it features different-sized event zones for various performances and exhibitions, and the shops are separated by low-level partitions. Through a professional guided tour conducted by the Property Management Department of Chinachem Group, participants can learn about the history, conservation, and revitalization efforts of Central Market.
