Technical Talk on “New LEED Rating System - Version 4 ... What’s Different from LEED v3? ”

Programme Highlights

The U.S. Green Building Council (USGBC) has announced that LEED (Leadership in Energy & Environment Design) version 4, the newest version of the LEED green building program, since November 2013 with the following highlights:-

- New market sectors: New market sector adaptations for LEED include data centers, warehouses and distribution centers, hospitality, existing schools, existing retail and mid-rise residential projects.
- Time saving support tools and resources: Simplified LEED credit submittal requirements, descriptive step-by-step reference guide materials with videos and tutorials, and a more intuitive technology platform.
- Building performance management: LEED v4 is focused on outcomes so that building owners have a better understanding of how to manage their buildings to meet full performance potential.
- New impact categories: Climate change, human health, water resources, biodiversity, green economy, community and natural resources.
- Higher requirements and new environmental concepts: LEED V4 raise the requirements for many of the credits from transportation, site, water, energy to indoor environmental quality, and adopts new environmental concepts including Environmental Product Declarations and Life Cycle Analysis
- International alternative compliance path: EU standards, ISO standards and other regional equivalent standards adopted in LEED V4

The technical talk will cover the introduction of New LEED Rating System – Version 4 for Building Design and Construction & Building Operations and Maintenance and the different from their Version 3. In addition, it will also have an experience sharing on the status of LEED registered projects in Hong Kong among the world.

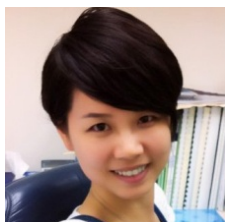

In 2013, together with GEES Tech, Ms. Lili founded L GEES, which later becomes the first independent USGBC Education Partner in Greater China. In 2014, she was invited by USGBC as honoured speaker in GreenBuild, the biggest green building conference in the world.
