A Talk on
**“Combating Climate Change:
Energy Saving and Carbon Emission Reduction in Buildings”**

Chartered Institute of Housing Asian Pacific Branch (CIHAPB) and The Hong Kong Institute of Housing (HKIH) have jointly organised a seminar for the background below:

Synopsis	<p>The Council for Sustainable Development (SDC) kicked start a new round of public engagement exercise in early August. This exercise aims to encourage stakeholders and the public to exchange their ideas on action plans for maximising energy efficiency and minimising carbon emissions in buildings, with a strategic focus on four core building user groups: catering, retail, office and household.</p> <p>Given that climate change is an imminent sustainable development issue and electricity consumption in buildings accounts for about 60% of greenhouse gas emission in Hong Kong, eleven “possible action areas” are set out in the Invitation for Response (IR) Document that focused on the demand-side management in electricity consumption and carbon emissions reduction in buildings.</p> <p>These actions are divided into two broad areas of mitigation measures: systemic enhancement and facilitation of behaviour change. Mr K S Wong and Dr Winnie Law are invited to address to CIHAPB & HKIH members on those key issues of the IR Document. (For e-version of IR Document, you may visit: http://www.susdev.org.hk).</p>
