Municipal Solid Waste (MSW) Charging Scheme”  
22 February 2024 (Thursday)**

<b>Content</b>	<p>In accordance with the "polluter-pays" principle, all waste disposed of in Hong Kong will be subject to charges based on its quantity starting from 1 August 2024. The implementation of MSW charging policies and regulations is expected to gradually achieve waste reduction and recycling measures.</p> <p>To ensure our members are well-prepared for the implementation of MSW charging, CIHAPB has cordially invited the Business Environment Council (BEC) to provide a talk, sharing their experience in the MSW Trial Scheme conducted in PRH estates and shopping centers during Phases 2, 3 &amp; 4 (2021 – 2023).
