International landmark Class A assets, including the Empire State Building in New York, Taipei 101, and Two IFC in Hong Kong, have used LEED for Existing Buildings to guide reductions in energy, water and maintenance costs, and improvements in occupant wellbeing. Global corporations recognize the value and consistency of LEED, and building owners and operators have used LEED certification to attract top tenants.


