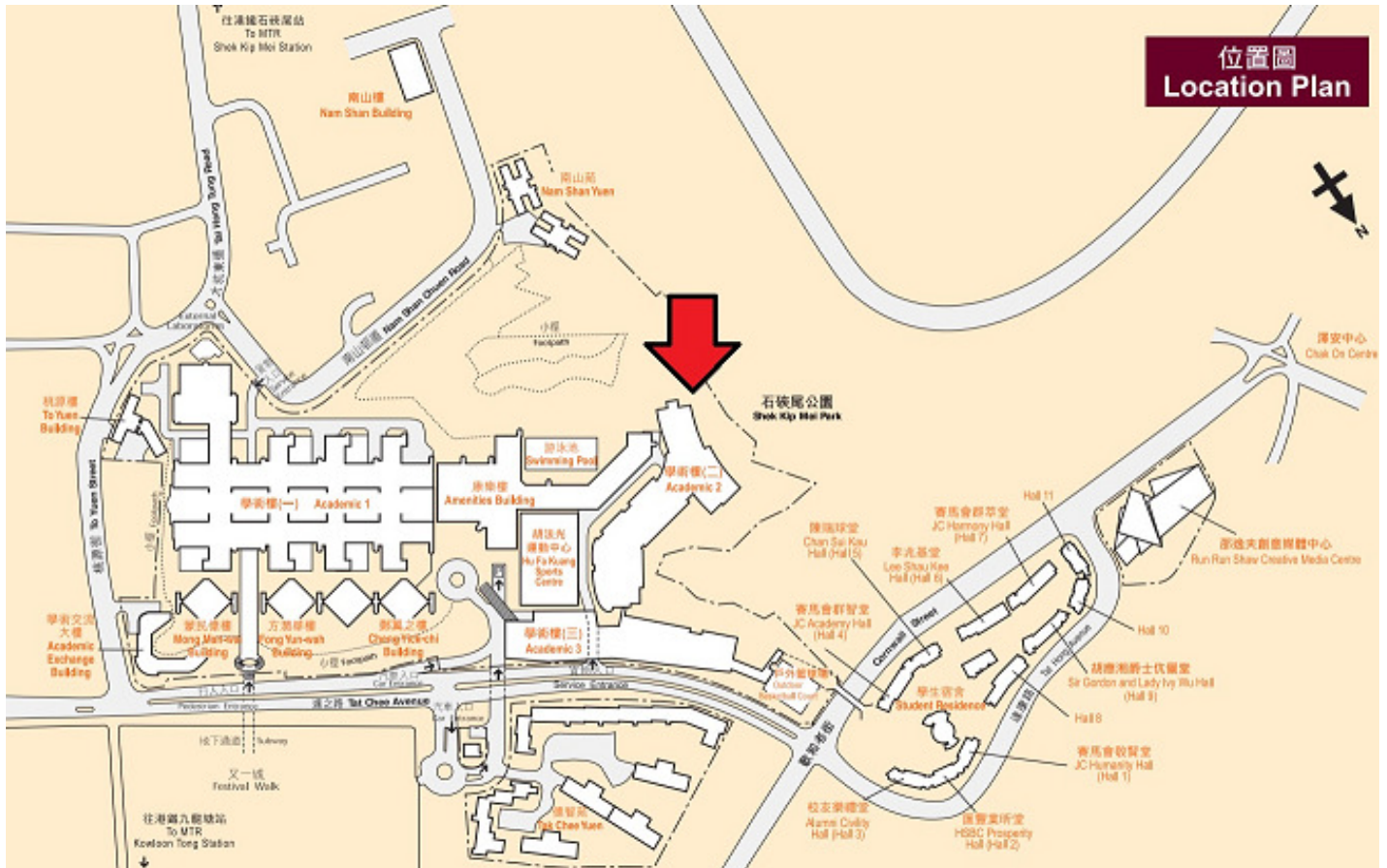

Arrived at Pedestrian Subway	Arrived at University Circle
<ol style="list-style-type: none"> <li>1. When you get off the MTR, look for Festival Walk exit.</li> <li>2. In Festival Walk, on Level LG1, there is a Pedestrian Subway which will lead you to CityU campus.</li> <li>3. After walking through the Pedestrian Subway, go down the staircase on your right and follow the directional signs, you will find yourself walking under a covered corridor alongside the garden which will lead you to the University Circle.</li> <li>4. Go along the covered walkway and follow the directional signs which will lead you to Academic 2.</li> </ol>	<ol style="list-style-type: none"> <li>1. When you drop off at the University Circle, go along the covered walkway and follow the directional signs which will lead you to Academic 2.</li> </ol>
