Content	To combat climate change, the Hong Kong Government unveiled the Energy Saving Plan for the Built Environment 2015-2025, which sets a new target of reducing Hong Kong's energy intensity by 40% by 2025. To achieve this, energy saving in commercial buildings is key, given that they consume 90% of Hong Kong's electricity. Air conditioning and lighting together account for about 50% of electricity use in commercial buildings. This seminar will share the latest energy management solutions that adopt Artificial Intelligence and IoT technologies. In particular, it will discuss AI-based chiller optimization, which can automate chiller plant operation and optimize energy consumption.
Speaker	Ir Stanley Lam, Senior Project Manager, Energy Management / CLPe Solutions Limited Stanley has been playing active role in CLPe to drive digital energy management solutions. His responsibilities include supporting ESG, net-zero carbon emissions and enhancing energy efficiency for community by adopting AI, IoT, big data and other state-of-the-art digital solutions.
