1980

The Branch published a booklet titled "Professional Housing Management in Hong Kong" outlining the history and development of the Branch and public / private housing in Hong Kong.

The Hong Kong Branch was born at a meeting held in April 1965. Mrs. J. Glover from the Hong Kong Housing Society was elected the first Chairman of the Branch.

Similar registration with the Chinese authorities was in progress.
