#### **Achievements in the Year**

Following the bumper development of Property market in the past two decades, there has been an increasing demand for professional Property management services in China. APB has successfully entered into partnership with Vanke, the leading developer in China, to launch the first housing management training programme for their senior staff in July 2008. Out of the 50 Vanke staff who attended the course, it is expected that about 40 of them would join CIH as Corporate Members through the Direct Final Route. Further collaboration in training with the company is being explored.

Coordinated by APB, students of Wuhan University's Property Management Faculty undertook internship training at Vanke's offices in various major cities in China, 6 of them were in Hong Kong for an intensive orientation programme in order to fulfill the Practical Experience Requirements for membership.

To support the industry and to promote professional development in the Region, APB co-organized housing conferences with the Wuhan University and the Hwa Hsia Institute of Technology in Taiwan respectively. The conferences served as a useful platform for exchanging knowledge and experiences in professional housing management.

In the coming years, we shall continue to explore more opportunities to further develop APB's business initiatives in the Region.

隨着過去20年物業市場的蓬勃發展,國內對專業物業管理服務的需求日增。本委員會最近成功夥拍國內首屈一指的發展商萬科,於本年7月安排其高層職員參加房屋管理培訓課程。預計其參加課程的50名人員當中,約有40位將會通過「最後直接」的渠道申請成為本會的專業會員。我們正研究進一步與萬科合作的可行性。


