# Chairman's Report 主席報告

Dear members.

I am taking this opportunity to thank for the full support you have rendered to us in the year. As a professional institute, we have been striving hard to promote the art and skill of property management as well as enhancing our professional standards in the Asian Pacific region. I am delighted to tell you that the profession is growing and becoming more significant in the community of the region and in China we have had hundreds of practitioners joined us as members. Nevertheless, with the enactment of the Foreign NGO Regulations in Mainland China, our development meets with uncertainties and challenges. I hope that with the support from our headquarters, we can be able to sort out this issue in the coming year.

With the approaching of a new year, it is time for me to conclude the major works done by us over the year of 2015.

#### Our works in Mainland China

Early this year, we have entered into an agreement with Bozhong Real Estate Management and Research Institute to provide training courses for potential members in southwestern China.

To provide better service and to strengthen our liaison with our members in Mainland China, a new Mainland China Membership Service Committee was established in March this year.

In September, a four days conference on the subject about a new property management era in internet upon the restructuring of eco-social system was held in Chengdu, China.

To facilitate payment of fees by our members in Mainland China, they can now use PayPal to pay for their fees. The Union Pay including the one card through will be ready for use early next year.

#### • 我們在中國的工作

今年年初,我們與重慶博眾房地產管理 研究院簽訂協議,在中國西南地區提供 會員培訓的機會。

亞太分會的中國會員事務委員會於今年 三月成立,目的是為了優化國內會員服 務和加強會員聯繫。

於今年九月,在中國成都舉辦以開啟移動互聯網時代 — "重構社區生態圈"為主題的四天會議研討活動。

為了方便國內的會員繳費,現在他們可以用支付寶支付學會費用,明年初還可 以選擇以銀聯卡付款。

## Amendment of Building Management Ordinance

In response to the public consultation for the Review of the Building Management Ordinance Cap. 344, a survey to solicit views of the members was carried out and a consolidated paper incorporated feedbacks from the members was sent to Home Affairs Department early this year.

## Property Management Services Bill

The Bill which requires property management companies and practitioners to obtain license is undergoing the second reading legislative process. We have joined with the other six property management professional institutes putting pressure to Home Affairs Department in tightening the professional requirements in the tier one property management practitioner licensing criteria. It is expected that second reading of the Bill will be completed in early 2016.

We have joined with the other three professional Institutes to appoint Hong Kong University Center of Urban Studies and Urban Planning to conduct a comprehensive research for Current manpower position in the property management industry and the total GFA managed by members of professional institutes.

# Validation of New Professional Programmes

We have assisted the Headquarters to validate a new property management programme run by Beijing University of Civil Engineering and Architecture in March. Graduates who have completed this programme could apply for CIH Chartered membership.

## Communications with headquarters

We have had more frequent communications with our headquarters in the year. In June, a delegation led by our immediate past chairman and vice chairman attended the Housing Conference in Manchester and met with the Governing Board to discuss some issues of major concerns.

## • 建築物管理條例的修訂

年初,為回應香港政府的建築物管理條例第344章諮詢,我們進行了會員意見調查,收集意見及整理後送交民政事務總署。

## • 物業管理服務條例草案

物業管理公司及從業員發牌制度草案已進入立法程序的二讀階段。我們聯同其他六個物業管理專業團體,曾經就一級物業管理從業許可標準的專業要求,向民政事務總署建議,預計法案二讀將於2016年初完成。

我們並且聯同其他三個房屋管理專業團體,委任香港大學城市研究及城市規劃中心進行一個香港物業管理行業、人力資源供應等情況的全面研究。有關報告可作日後發牌政策實施的參考。

#### • 完成新的課程認證

三月,我們協助總部認證北京建築大學 經管學院開辦的課程,完成課程及有關 規定的畢業生可以申請成為本會特許會 員。

## • 與總部的溝通

這年我們與總部有頻密的溝通。亞太分會前主席及副主席率領的代表團於六月參加了曼切斯特市房屋會議,並與總部管理委員會會面,商討彼此關注的事項。



During the Presidential visit of Ms. Geraldine Howley in August, we have arranged her to meet with our staff in our new office. Another visit to Shenzhen was arranged for introducing to her our service delivery in Mainland China.

To enhance the communications with headquarters, video conferences with their directors were held throughout the year.

# **Continuing Professional Development** (CPD)

Mandatory CPD for members in Hong Kong is taking effect this year. Renewal of Membership in 2016 is required to have the CPD requirements completed. We have prepared a web page in our web-site to facilitate members completing their CPD.

## **Membership Drive**

The number of members in Hong Kong remains stable. However, we notice that some of our loyal members are reaching the retirement age, and they will be gradually replaced by young members. We expected that the growth of membership in future will be coming from areas other than Hong Kong.

## **Preparation for APB 50th Anniversary**

APB is reaching her 50th Anniversary in 2016. To celebrate this meaningful year, we have established a committee chaired by our immediate past chairman, Professor Yip to prepare for the 50th anniversary events. The committee initially planned a charitable movie, two seminars, one in Macau and another in Shenzhen. In Hong Kong, a Housing conference would be held together with the annual dinner in November.

Finally I have to thank for the commitments and contribution of our Executive Committee and the hard work of the secretariat in accomplishing our mission in the year.
