Secretary for Transport and Housing

Professor Anthony Cheung Bing-leung, GBS, JP

Professor Anthony Cheung Bing-leung was appointed Secretary for Transport and Housing on 1 July 2012. Before assuming this post, Professor Cheung was the President of The Hong Kong Institute of Education.

As the Secretary for Transport and Housing, Professor Cheung is the Chairman of the Hong Kong Housing Authority, Hong Kong Maritime and Port Board, Hong Kong Logistics Development Council and Aviation Development and Three-runway System Advisory Committee. He is also board member of MTR Corporation Limited; Kowloon-Canton Railway Corporation; Airport Authority Hong Kong and Hong Kong Mortgage Corporation, as well as member of the Council for Sustainable Development and Economic Development Commission.

Professor Cheung received his bachelor's degree in social sciences from the University of Hong Kong, master's degree in public sector management from the University of Aston, UK, and PhD in government from the London School of Economics and Political Science, University of London, UK.

Before joining the Government, Professor Cheung held a number of public service positions including Non-official Member of the Executive Council and Chairman of the Hong Kong Consumer Council.

Dr. Misa Izuhara

Dr. Misa Izuhara is a reader in Comparative Policy Research and the Head of the Centre for Urban and Public Policy Research at the School for Policy Studies, the University of Bristol, UK. She has been undertaking research extensively, both nationally and internationally, in the areas of housing and urban change, ageing and intergenerational relations, and comparative social policy analysis between the East and the West and also within the region. Her research projects include cross-national comparative research on 'Housing assets and intergenerational dynamics in East Asian societies' funded by the UK Economic & Social Research Council. She is the author of *Housing, Care and Inheritance* (Routledge, 2009) and the editor of *Handbook on East Asian Social Policy* (Edward Elgar, 2013). She is currently the Co-Editor of *the Journal of Social Policy* and the president of the East Asian Social Policy Research Network.
